Other than this restriction, CHS Elburn will accept *Agrisure-Duracade* and *Qrome* at all of our elevators including river terminals in Morris, IL, Davenport, IA, and ethanol plants CHS-Rochelle and CHS Annawan. This policy is subject to change.
